Table of Contents Clarity (Lite)

To facilitate the orientation in the **5.0 vs 4.0** manual and **Clarity** chromatography station, different fonts are used throughout the manual. Meanings of these fonts are:

Instrument (blue text) marks the name of the window, to which the text refers.

Open File (italics) describes the commands and names of fields in **Clarity**, parameters that can be entered into them or a window or dialog name (when you already are in the topic describing the window).

WORK1 (capitals) indicates the name of the file and/or directory.

ACTIVE (capital italics) marks the state of the station or its part.

The bold text is sometimes also used for important parts of the text and the name of the **Clarity** station. Moreover, there are text sections written in format other than normal text. These sections are formatted as follows:

Note: Notifies the reader of possibly interesting information.

Caution: Warns the user of possibly dangerous or very important information.

## Marks the problem statement or trouble question.

Description: Presents any closer information on the problem, describes its causes etc.

Solution: Marks the response to the question, presents a procedure how to remove it.

# 1 Preamble

This document will guide you through the news and improvements in the **Clarity** Chromatography Station version **5.0**. It describes news developed till version **5.0.5** and the most interesting include:

- Dynamic localization.
- MS extension for processing mass spectrometry data.
- Manual control of pumps during gradient run.
- Multiple ISTD.
- Various Clarity improvements and bug fixes.
- · New and updated control modules.

# 2 Clarity

# 2.1 Dynamic localization

Clarity now supports new feature of dynamic localization. It enables users to switch to English, Chinese, Russian, Spanish, French and German while running Clarity.

There is no need to install language packages separately. You can set the preferred language at the beginning of the installation process or change it later using *Help - Languages* menu command from the main Clarity window.

Switching to a different language was never so easy!

After selecting desired language, user is prompted to restart Clarity.

## 2.3 MS Extension Full version

New Mass Spectrometry extension is intended for data acquisition and evaluation of data measured on selected MS Detectors. See the chapter "New and updated control modules" on pg 16.

You can try the **MS Extension** in **Clarity Demo** which can be downloaded from **www.dataapex.com** together with the manual. In the **Clarity System Configuration**, there are new **MS** options in the *Instrument Type* dropdown list.




Fig 4: MS Extension in the System configuration

The MS Extension brings the following features to the Clarity station:

MS Chromatogram window - standard Clarity Chromatogram window
was modified to display the spectral information. The graph pane now
holds one more graph showing the spectrum at any given time or at a time
span, which is noted in the top-right corner in the legend area.




Fig 5: Chromatogram window with MS extension

- MS Method MS method allows the user to select the extracted signals on
  which the compounds will be identified and quantified. Each compound
  may use different reference signals, so that more than one compound may
  be identified in any part of the chromatogram.
- Library search Clarity MS Extension allows the user to use spectral libraries for peak identification and/or compound confirmation.
- NIST Libraries Clarity uses the NIST Library format for storing spectra, and works flawlessly with commercial NIST Libraries or those created by the user.

 Automatic Compound Search - Clarity allows to search any selected signal automatically for the presence of spectra that are defined in the spectral library.

The following standard **Clarity** features will also help the user to make the best of the **MS** analysis in **Clarity**:

- User calculations the user can define custom calculations in the Result
   Table and Summary Table. With the use of the integrated editor you can
   create your own columns from the original ones and use individual
   mathematical functions.
- Reports user selectable report sections, WYSIWYG formatting of Graphs and Tables, and the possibility to report the spectral information for any peak in the chromatogram.
- Batch automatic batch processing, display, export or print of any number of chromatograms.
- Summary Result Table displays and prints selected results from all simultaneously displayed chromatograms.

## 2.4 PDA enhancements

Possibility to use **multiple spectral detectors** on Clarity instrument (**DAD+FLD** combination etc.)




Fig 6: PDA Chromatogram window - Selecting Spectral Data

 Newly in the PDA Chromatogram window there is option to change between multiple spectral detectors. This option is accessible via the Spectrum - Select Spectral Data command from the menu. Choice of the detectors of course depends on the detectors used. Fig 6 on pg 7. shows option to view Spectral data from different spectral detectors. Note this option serves only for displaying different spectra (DAD or FLD).




Fig 7: Chromatogram window - Selecting PDA Spectrum

Option for multiple spectral detectors has been implemented in the
method setup. Chromatogram window copies the settings from the
method setup and displays them under the Measurement Conditions tabPDA Method tab. Selection of the appropriate detector is done via the
drop down list as displayed by Fig 7 on pg 8. Note that chosen spectrum is
used in the method and for further calculations.

## 2.5 Other enhancements in extensions

#### **Extension GPC:**

- NormHT calculation can now be based on the MW distribution graph (previous Clarity versions, default) or on the chromatographic peak (new, to be comparable to other GPC software's).
- The Method Setup, GPC Advanced tab has been removed.

#### **Extension CE:**

 Calculation of Apparent Mobility and Effective Mobility is now available in the Method Setup - Performance tab.

#### **Extension SST:**

 Double click in the SST table will activate the respective chromatogram in graph pane.

## 2.6 Calibration

Command View in the Chromatogram window will now open both the
active chromatogram and the linked calibration in the Calibration window.
Before that, clicking the View button opened only the calibration but left
the previously opened chromatogram which in some cases could have
been misleading.




Fig 8: Chromatogram window with the linked calibration




Fig 9: Calibration window with the active chromatogram




Fig 10: Chromatogram with named groups defined in the Calibration

 Defined Named Groups in the Calibration will be displayed in the Chromatogram - in the Result table below the Total Row. One compound can be present in several named groups. Not supported in the Chromatogram - Summary table. For more details see Fig 10 on pg 10.

Calibration: New response base: Area Percent - for special calculations
in clinical diagnosis. Calibration using this option is based on the area
percentage of peaks. Only peaks used in calibration are summed into the
whole (100%), thus it is required to add them all into calibration, even
when user does not need to calculate their results.

This option is accessible from two points. The first one is located in the Calibration window - table compounds under RB column (Fig 9 on pg 10.)




Fig 11: Calibration window - cut of Area Percent

 P would stand for Area Percent. The second one is located in the Calibration window - specific compound tab (e.g. Ethanol) - Response base - Area Percent. Calibration window with Area Percent is seen in Fig 11 on pg 11.

# 2.7 Sequence table




Fig 12: Sequence table - newly editable Run, Std. and Lvl. columns

Newly in the sequence table, *Run*, *Std.* and *Lvl.* columns are editable for measured rows. Modified settings will be applied during batch reprocess. Notice that aforementioned columns are not dimmed as the others as demonstrated by **Fig 12** on pg **12**.

This new function is advantageous for example if you want to apply new integration table or apply different calibration or perhaps by accident assigned Standard to a different level - wide range of application. Along with the batch reprocess it brings a new level of automatization.

# 2.8 Manual control of pumps during gradient run

Manual control of pumps during gradient run for preparative chromatography now includes 2 new buttons:

- Hold (Resume)
- Manual Flow




Fig 13: Device Monitor window - current status

- Hold 1 button in Fig 13 on pg 13. will keep the current gradient conditions until pressing Resume again. Note that the Hold button does not affect acquisition.




Fig 14: LC Control Manual Flow window - Gradient Table

- Manual Flow 2 button in Fig 13 on pg 13. allows editing of the gradient table during running acquisition by opening the LC Control Manual Flow window as seen in Fig 14 on pg 13.

After clicking the *OK* button ③, changes made to the gradient table will be applied for the rest of the run. Supported only for selected pumps. Note that buttons *Hold* and *Manual Flow* affect only the performance of the *Gradient Table* - it will not affect the running analysis itself. The performed gradient will be stored in the measured chromatogram. Succeeding analyses are performed by the original *Gradient Table* - unless the altered *Gradient Table* is *Saved as* in the **template method**.

# 2.9 Various improvements in Clarity

 Newly, the number of available signals in chromatogram has been increased from 12 to 32.

- Installation Options (Typical, Custom, Full) selected during installation are remembered during updates or reinstallations.
- Wait dialog is now displayed during lengthy operations.
- Added a new command Reorder Monitors in the Device Monitor. Allows to change the order of the individual panes and thus improves the overall organisation of the Device Monitor.
- Create Label option Active Chromatogram renamed to Active Signal.
- Detector delay is now enabled also on the first signal.
- Command line parameters: new parameter "printPDF".
- Some errors were not correctly recorded in Daily Audit Trail.
- All command line parameters received are now recorded in Audit Trail.

#### Clarity2Go enhancements:

- Added support for proxy server setting in Clarity2Go Configuration / Advanced dialog.
- Enhancements in the security of **Clarity2Go** option to set password to restrict access to view the status of running analysis.
